

**MINUTES OF THE MEETING OF REPTON PARISH COUNCIL HELD IN THE
COMMUNITY ROOM, FISHER CLOSE, REPTON AT 7.30 P.M. ON
MONDAY 12TH FEBRUARY 2018**

2453/18 APPROVAL OF MINUTES OF THE MEETING 8TH JANUARY 2018

RESOLVED: That they be signed as a true record.

Standing Orders lifted for Public Speaking and Planning

2454/18 PUBLIC SPEAKING:

The Bursar, Repton School, advised the meeting that the school did not own the land bordering Willington Road, where the knotweed was located; the District Council was currently pursuing the landowner regarding this problem. Repton School contributed to the local area by cleaning the area around the church lych-gate towards The Cross and the bus stops and, following agreement with DCC, would be paying for the tarmac resurfacing of the 'sausage' area, close to the lych-gate.

A further member of the public thanked the Parish Council for contacting Miller Homes regarding the dead hedge, close to its development, as new planting had now taken place.

RESOLVED: 9 2017 0194 – Outline application (all matters except for access to be reserved) for the residential development of up to 13 dwellings and associated works (including the demolition of Askew Lodge) at Askew Lodge, Milton Road, Repton – Appeal lodged at The Planning Inspectorate – in addition to the comments previously submitted (2281/17) the Parish Council would add: that the emerging NDP is now at an advanced state, having been formally submitted to the local planning authority for examination. This makes the NDP, in our view, a material consideration:

The application is in clear conflict with NDP policies H1 (POLICY H1: THE LIMITS OF DEVELOPMENT: The limits of development for the villages of Repton and Milton will be maintained as identified on the proposal maps for each village.) and OS2 (POLICY OS2: THE VISUAL IMPACT OF NEW DEVELOPMENT ON VIEWS FROM THE COUNTRYSIDE MUST BE MINIMISED: An assessment of views to and from a proposed development should be provided to show how the negative visual impact will be minimised through the design of the site location, layout, buildings and landscaping and how it will be consistent with the findings of the Landscape Character and Visual Amenity Assessment (CEF6) - the proposed site includes an area of high visual sensitivity.

This application was also rejected by the South Derbyshire District Council Local Plan Part 2 Inspector and there is evidence that the recent burst water mains on Milton Road was due to the increased number of new houses in this area.

There would be no comments on the other planning applications.

Standing Orders Resumed

2456/18 COUNTY, DISTRICT AND PARISH COUNCILLORS' REPORTS

- a) District Councillor Stanton reported that SDDC would meet on the 26th of February to set the Council Tax for the next financial year. The increase was expected to be 1.9%, which would involve reducing the reserves, if spending continued at the current rate, the reserves would be exhausted in 3 years.
- b) District Councillor Stanton advised the meeting that, in his view, the s106 monies previously allocated to Repton Village Hall were contingent on a rebuild, and not a refurbishment project.
- c) Councillor Lloyd reported the poor state of the local roads and said that the Clerk would include advice on how to report potholes to DCC in the Jottings.
- d) Councillor McArdle reported that individual local residents were now borrowing the litter picking equipment and undertaking this work themselves. District Councillor Stanton would supply further litter pickers and a further small group activity would be organised.
- e) Councillor McGahan, together with the Chairman, had met with representatives from SDDC to discuss the provision of additional land for the Arboretum. The conclusions were: the underground electrical cable would not prevent planting; a rough grass area would have to be left around the edges; there could be no fencing, and only trees stipulated by SDDC could be planted – typically small trees 2 – 3m high. The Parish Council would now await further advice from Bernard Sheridan, SDDC.
- f) Councillor Steel had provided the Clerk with a plan of where Milton residents would prefer the planters to be located.
- g) Councillor Thomas raised the problem of speeding traffic through the village. Councillor Thompson said that road calming /speed limiting measures have previously been suggested to DCC, however enforcing any changes was beyond the remit of the Parish Council. The Parish Council would instead need to try to gain County Council support for a specific proposal. Speedwatch, using a radar gun had previously been organised by Repton School and the Clerk would ask DCC if a further exercise could be organised. Councillor Dickson reported that traffic issues also concerned Willington Parish Councillors and highlighted the need for a further bridge across the river Trent. The Chairman stated that the Area Forum was a good opportunity to raise such issues.
- h) Councillor Thomas also asked for a progress report on the damaged sign. The Chairman reported that a Buxton Company was to provide a quote for the repair work.

2457/18 CLERK'S REPORT

a) Repton Primary School Leavers' Party

The Clerk had received a letter from parents at the Primary School requesting use of The Mitre Field for their Leavers' Party on 20th July 2018.

RESOLVED: The request would be granted subject to our usual terms: The Parish Council cannot grant exclusive use of the field; we cannot provide insurance cover for the party and the Parish Council has a policy of not allowing bouncy castles or large inflatables on The Mitre Field. Should they wish to consider using any small inflatable item they should contact us prior to the event. In addition no late night noise or alcohol for the adults could be permitted.

b) Benches Update

Councillors considered suitable locations for the bench which would be purchased by a local resident in memory of her son.

RESOLVED: The corner of Springfield Road and Mount Pleasant was suggested as a suitable location, Councillor McArdle would speak to the

nearest householders before proceeding. The existing bench would be sited on **the slabs off Fisher Close, on the slope of the footpath.**

c) Request to sell Food at Football Matches

Repton Casuals had asked if hot food, could be sold at football matches.

RESOLVED: Repton Casuals would need to gain approval from Environmental Health, SDDC, before this request could be granted.

d) Co-Option of Councillor

The details of the one person, who had applied for co-option, had been circulated.

RESOLVED: Jonathan Sheldon was co-opted to the Parish Council

2458/18 CHAIRMAN'S ANNOUNCEMENTS

The Chairman expressed thanks to John Shortt, a previous Councillor, for continuing the maintenance of the Parish Council website. The Facebook page was no longer active.

2459/18 COUNCILLORS' INTEREST GROUPS

The Clerk had circulated an updated list prior to the meeting.

RESOLVED: It was agreed to maintain the 3 current working groups – Neighbourhood Development Plan; Repton Village Hall and Broomhills which should be agenda items at each meeting. Some groups were still in need of further volunteers and a revised list would be recirculated. Further groups could be added, at a later date, if required.

2460/18 BROOMHILLS FIELD & PAVILION

Councillor Steel had circulated a conditions report on the pavilion prior to the meeting and reported that, with regard to the underpinning and crack, no further movement had been noted. Councillor Steel offered to prepare any future work schedules required. The Chairman and Councillor McGahan were to arrange a meeting with SDDC regarding the refurbishment of the building and the use of s106 monies. The Chairman reported that the asbestos survey had been carried out and a fire blanket required specialist disposal, it was also possible to have an optional air check at the time of disposal.

RESOLVED: The Clerk would order the specialist disposal of the fire blanket and cleaning of the area by J S Environmental Ltd at a cost of £180.00 + vat. The optional air check would not be ordered.

The Chairman lifted Standing Orders

2461/18 REPTON VILLAGE HALL PROPOSAL

The next meeting of the joint working group was scheduled for the 20th of February. Councillor Rainey said that an agreed statement of requirement should be agreed at the joint working group meeting which would enable the Parish Council to move forward at the March meeting.

RESOLVED: The Parish Council would await the report of the joint working group (20th February).

The Chairman reinstated Standing Orders.
